All families must pay a \$125.00 non-refundable annual registration fee per family for the year, regardless of part-time or full-time enrollment, for those who enroll by May 31, 2009. Starting June 1, 2009 the fee will increase to \$150.00. This fee will be used to cover insurance, supplies, and copying. The tuition per student each month is \$20.00 for one class, \$35.00 for a half-day and \$60.00 for a full day of classes. **Please make checks payable to SAGE.** September's tuition will be due on the first day of classes. All other tuition is due on the first Friday of each month and no later than the seventh of each month. **A \$20.00 late fee will be added for all checks received after the seventh of each month.**
